Scholarships: "Bourses de la réussite étudiante" (8001-15/18) :

In planning the capital campaign, *Campus Montreal*, the University of Montreal along with HEC Montréal and École Polytechnique du Montréal identified student scholarships as one of the most crucial areas for funding. Under the theme, *Votre don ira loin – les étudiants façonneront l'avenir de notre société*, the university set an ambitious target of raising \$75 million for scholarships.

This fund will enable the university to support the current and future needs for student scholarships. This will be ensured through the placement of 80% of all donations in an endowment fund that would allow the long-term sustainability of the program. The remaining 20% will be direct-spent on scholarships on a yearly basis.
